3.0 **Cloppenburg Park Irrigation**

On 30th July 2019, councillors received the following note:

The Council meeting on the 16 July resolved: Resolution No. 2019/443:

That the Chief Executive Officer investigate and arrange to proceed on the existing contract to irrigate Cloppenburg Park.

Moved: Cr Neil White Seconded: Vice-President Tom Dyer

Yesterday the President forwarded the need to increase the 2019/2020 budget by \$34,500 to complete the works. (see attached)

This additional funding would need to be from reserves as there is no identified surplus so early in the financial year.

The shortfall was not included when developing the budget as the \$19,000 was the only identified revote.

I have arranged for the contract to proceed with variation No 2 and the contractor has agreed to wait until Friday for acknowledgement.

The President has asked for a special meeting Thursday as Council members need to acknowledge the need to address the short fall and agree to proceed.

Coppenburg Park Irrigation (all figures are GST free)

A review of the finances to supply and install a bore pump, booster pump, electrical and sprinkler system to irrigate Coppenburg Park has identified a \$34,500 short fall in the budget for 2019/2020. The budget currently has \$19,000 identified to complete the work.

The following is an audit of the finances.
