Registration is annual and due on **1 September each year throughout the Darwin Regional and Rural Area**, and is reciprocal with participating Top End Councils including; City of Darwin, City of Palmerston, Coomalie Community Council and Litchfield Council. This means that if you move to or from another participating Council during that year, your dog registration is recognised in that new local government area. Your name and contact details must be the same and proof of your current and previous residence must be shown.

Please ensure that your dog's details are kept up to date and that the new Council is notified of change of ownership of the dog, change of address where the dog is kept, if the dog leaves the area and/or if the dog is deceased.
